How can I find out which sessions are approved for the type of continuing education hours I need?

- Go to the [HIMSS24 Session Search](#) page of the HIMSS24 website and filter by **CE Credit**. You will then be able to search each day for sessions that fulfill your requirements.

How do I keep a record of the sessions I’ve attended and the credit I received?

- There are two ways to record your sessions and hours.
 - Go to the [HIMSS24 Continuing Education page](#) and click on the **Claim CE Credits button**.
 - **On the HIMSS24 Mobile App Discover screen, scroll to About HIMSS24 → Discover → Continuing Education Credits.**
 - Once you have logged into the [HIMSS24 Conference CE Claiming Site](#), you will be able to enter the sessions you attended and print a transcript. You will also be given the option of printing certificates or having them emailed to you. **NOTE:** You will need to use the name and email that you used to register for the conference. If logging in by badge number, use all numbers and do not add hyphens.
- Claiming individual types of continuing education hours credit
 - **ACPE: must be claimed by April 10, 2024.** ACPE sessions must be entered into the HIMSS23 CE claiming system within four weeks after the Conference ends. Sessions entered after that date will not be submitted to the ACPE. Please check the ACPE Tracking Form found at [HIMSS24 Continuing Education page](#) for session Activity Type.
 - **CHES/MCHES (National Commission for Health Education Credentialing, Inc.): must be claimed by March 31, 2024.** CHES/MCHES sessions must be entered into the HIMSS24 CE claiming system within four weeks after the Conference ends. Sessions entered after that date will not be submitted to the NCHES. Please check the NCHES Tracking Form found at [HIMSS24 Continuing Education page](#) for session Activity Type.
- **Please note** that you are responsible for providing information about the continuing education

hours you've received to the proper accrediting body.

- **CHIME members** and Affiliates may claim their continuing education hours by entering them into the Self-Reporting Tool on the CHIME website.
- Finalize the PMI PDU Claim Submission process by logging onto <https://ccrs.pmi.org> to claim your Category A PDUs by using the PMI Activity # provided by HIMSS on the HIMSS24 PDU Tracking Form found on the [HIMSS24 Continuing Education page](#). HIMSS does not supply PDUs earned by attendees to PMI.
- For information about other types of credit, please contact the appropriate accreditation body.
- CAHIMS/CPHIMS sessions are included in the CE claiming site. Please use the CAHIMS/CPHIMS Tracking Sheet located at [HIMSS24 Continuing Education page](#) to track the activities you attend which are eligible for this credit.

How long will the CE system be available on the HIMSS website?

- The system will be open through December 31, 2024.

Will any recorded sessions be available for continuing education hours after HIMSS24 has concluded?

- Yes. CAHIMS/CPHIMS/CPDHTS will be available for all recorded sessions. Other types of continuing education credits, both clinical and non-clinical, will be available on some session recordings.
